D So and I had, I think I had neither course, at Gainesville that I got credit for here to you know Social Science .

M Right. Did you live on campus?

D Yes, yes. Uh, they had been building the WWII for apartments right across the street from campus and I uh; I lived there the spring semester '53 then all of '53-'54.

M Where did you eat?

D Right across the street in a you know uh cafeteria, and then when uh, the financial uh situation warranted, went off campus.

M Right.Ok, so Mr. Szabo gave you a job here on campus, you were part of work study and you were assigned to do what?

D Well, that uh the end f the semester my first job as cleaning ut all the drms r apartments, later y ant to call them. And then I as prompted touh, ming. And this I think is an interesting story Dr. Spieyidentlyand epartmentdidnt spend er \$50.00 without his approval, but Dr. Spiey ut f toward Frank Sabopurchased a tractor , a ming tractor. Yu knowiding type f tractor. And he [moment presents hearing wd] surprised Dr. Spieyhe he gt back. And the morning the Dr. as expected back n the train, Frank had me , he said, Y u godn there and mthe front law ." Which as Dr. Spieypride and joy knofv chuckles] and

[sigh] I don't think, I didn't see any checks, I think it was primarily uh room and board and I was uh, since uh to ROTC. I had completed two years of ROTC at the University of Florida, the basic course system, and then I came here in January I came over and sat with Colonel Dickinson, was the PMSMT. And he wanted me to go back and repeat the second semester of basic ROTC. But I didn't want to do that, so anyway at the end of the semester, uh I went over and sat with Colonel Dickinson again and I said, "You know I would like to get back in the program." And he had every reason to say I gave you a chance to come in and you didn't want to. Anyway he let me double up and take the two years of advance training in one year. And I was the last guy out at Bunt Hill, because the Department of Defense changed that regulation that summer. Saying that you could no longer double up, you had to go you know all four years.

And then was required chapel I think on Wednesday. Uh, for maybe like 11:00 to 12:00. Then somehow got appointed to chapel committee the last year I was here, '53-54. And uh, we were responsible for getting speakers, so you know an Episcopalian, so I contacted the Episcopal rectory in downtown Lakeland and he came and spoke. I don't remember too many of the speakers, they had. But we had Dr. Bethune, was the funder of ...

D Yes, she came over here, and I would say I remember she was the most well-known speaker that we had that year.

M Was that when Frank Lloyd Wright showed up that year

D No I understand he came periodically and would walk around, but no incidentally he was a Clegg, I don't know where he went to college, but uh.

M Hmm. So, with the buildings being built here it generally impacted somebody uh, '54 let's see, Ordway would have been being built by '54, uh with Polk Science. Were they still building that in '54?

B Did you ever hear about anybody ever going to Scott Lake course back then, all it is now is housing developments and stuff like that. Before it use to kind of be the place where a lot of people could go and have parties and stuff.

B No no I hitched hike one time, uh it must have been the second summer that I was at Gainesville. They use to have house parties, with the week the high schools let out. In those days they had high school fraternities and sororities and they different groups would rent a house and of course uh, the gals would have two or three parents chaperoning us and so forth. I think one time I hitched hike over from Orlando over to Daytona. But I could usually get a ride with somebody. And I didnt get a car of my own until I had finished out the basic at Fort [Coughs] excuse me, Gordo. And uh, in October 54, I bought a car in Augusta and then when I got orders to Germany officers and senior non-coms the government would transport your vehicle over there, so ...
